The undersigned, for the purpose of forming a general business corporation under the laws of the State of Idaho in compliance with the Idaho Business Corporation Act (Title 30, Chapter 29, Idaho Code) (the "Act"), does hereby certify, declare, and adopt the following Articles of Incorporation.

**ARTICLE I  
NAME**

The name of the corporation is Prairie Machine Werks, Inc. (the "Corporation").

**ARTICLE II  
AUTHORIZED SHARES**

The Corporation shall be authorized to issue ten thousand shares (10,000) shares of common stock having no par value.

**ARTICLE III  
DURATION**

The Corporation shall have a perpetual duration.

**ARTICLE IV  
PURPOSES**

The Corporation is organized and shall be operated for the purpose of engaging in any lawful business.

**ARTICLE V  
BOARD OF DIRECTORS**

All corporate powers shall be exercised by or under the authority of, and the business and affairs of the Corporation shall be managed under the direction of, its Board of Directors, subject to any limitation set forth in the Corporation's Bylaws or any Shareholders Agreement adopted under Section 30-29-732 of the Act.

**ARTICLE VI  
INDEMNIFICATION**

The Corporation shall indemnify the Directors and Officers of the Corporation to the fullest extent permitted by the Act, as the same exists as of the date hereof or may hereafter be amended (but, in the case of any such amendment, only to the extent that such

amendment permits the Corporation to provide broader indemnification rights than the Act permitted prior to such amendment).

**ARTICLE VII  
LIMITATION OF LIABILITY**

No Director shall be liable to the Corporation or its Shareholders for monetary damages for breach of fiduciary duty except liability for: (i) the amount of a financial benefit received by a Director to which the Director is not entitled; (ii) an intentional infliction of harm on the Corporation or the Shareholders; (iii) a violation of Section 30-29-832 of the Act; or (iv) an intentional violation of criminal law.

**ARTICLE VIII  
REGISTERED AGENT**

The initial registered agent of the Corporation shall be indicated on the records filed with the Idaho Secretary of State. The name of the Corporation's registered agent is Adam Hanna, whose address is 336 Hazen Lane, Orofino, Idaho 83544. The Corporation may change its registered agent from time to time at the direction of the Board of Directors.

**ARTICLE IX  
AMENDMENT**

These Articles of Incorporation may only be amended, restated or otherwise modified by unanimous vote of the Shareholders.

**ARTICLE X  
INCORPORATOR**
