- 1. NAME. The name of the corporation is Full Throttle Enterprises, Inc.
- 2. <u>AUTHORIZED SHARES</u>. The aggregate number of shares the corporation is authorized to issue shall be 1,000 all of which shall be common voting stock.
- 3. <u>REGISTERED OFFICE AND AGENT</u>. The registered office of the corporation is 10515 W. Brownstone Drive, Bolse, Idaho 83709, and its registered agent at that address is Gary M. Holt.

- 5. <u>VOTING ENTITLEMENT OF SHARES</u>. (A) Except as provided in sections (B) and (D) of this Article, each outstanding share, regardless of class, is entitled to one (1) vote on each matter voted on at a shareholders' meeting. Only shares are entitled to vote.
- (B) This corporation is not entitled to vote treasury shares. The shares of this corporation are not entitled to vote if they are owned, directly or indirectly, by a second corporation, domestic or foreign, and this corporation owns, directly or indirectly, a majority of the shares entitled to vote for directors of the second corporation.
- (C) Section (B) of this Articles does not limit the power of this corporation to vote any share, including its own shares, held by it in a fiduciary capacity.
- (D) Redeemable shares are not entitled to vote after notice of redemption is mailed to the holders and a sum sufficient to redeem the shares has been deposited with a bank, trust company, or other financial institution under an irrevocable obligation to pay the holders the redemption price on surrender of the shares.
- 6. <u>CORPORATE PURPOSE</u> The purpose for which this corporation is organized is the transaction of any and all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.
