PURSUANT TO the Idaho Model Entity Transactions Act, *Idaho Code Ann.*, title 30, chapter 22 (as amended) (the "*Entity Act*") and the Idaho Uniform Limited Liability Company Act, *Idaho Code Ann.*, title 30, chapter 25 (as amended) (the "*LLC Act*"), the undersigned manager of Hamilton Hay, LLC (the "*Company*") sets forth the following matters as the Company's statement of domestication (the "*Statement*"):

1. *Name and Jurisdiction of Domesticating Entity.* The Company was formed on 27 February 2001 as Hamilton Hay, LLC, which is a Utah limited liability company under the Utah Revised Limited Liability Company Act.

2. *Name and Jurisdiction of Domesticated Entity.* The members of the Company desire that the state of registration for the Company be transferred from Utah to Idaho, i.e., that the Company be domesticated in Idaho. From the date of filing of this Statement with the Idaho Secretary of State, the Company shall be known as Hamilton Hay, LLC, an Idaho limited liability company and shall be governed by the LLC Act.


3. *Effective Date.* This Statement shall become effective on the date of its filing with the Idaho Secretary of State.
