3 (3) To purchase or otherwise acquire, hold, sell, exchange,
4 pledge, hypothecate, underwrite, deal in and dispose of stocks, bonds,
5 notes, debentures, or other evidences of indebtedness and obligations and
6 securities of any corporation, company, association, partnership, syndicate
7 entity, or person, domestic or foreign, or of any domestic or foreign
8 state, government, or governmental authority or of any political or
9 administrative subdivision or department thereof, and certificates or
10 receipts of any kind representing or evidencing any interest in any such
11 stocks, bonds, notes, debentures, evidences of indebtedness, obligations,
12 or securities; to issue its own shares of stock, bonds, notes, debentures,
13 or other evidences of indebtedness and obligations and securities for the
14 acquisition of any such stocks, bonds, notes, debentures, evidences of
15 indebtedness, obligations, securities, certificates, or receipts purchased
16 or acquired by it; and, while the owner or holder of any such stocks,
17 bonds, notes, debentures, evidences of indebtedness, obligations, securities,
18 certificates, or receipts, to exercise all the rights of ownership in respect
19 thereof; and, to the extent now or hereafter permitted by law, to aid by
20 loan, subsidy, guaranty, or otherwise, those issuing, creating, or
21 responsible for any such stocks, bonds, notes, debentures, evidences of
22 indebtedness, obligations, securities, certificates, or receipts.

23 (4) To purchase or otherwise acquire, hold, exchange, pledge,
24 hypothecate, sell, deal in, and dispose of mortgages covering any kind of
25 property.

26 (5) To purchase or otherwise acquire, undertake, carry on,
27 improve, or develop, all or any of the business, good will, rights, assets,
28 and liabilities of any person, firm, association, or corporation carrying
29 on any kind of business of a similar nature to that which this corporation
30 is authorized to carry on, pursuant to the provisions of these Articles;
31 and to hold, utilize and in any manner dispose of the rights and property
32 so acquired.

1 (6) To make any guaranty respecting dividends, stocks,
2 securities, indebtedness, interest, contracts, or other obligations so
3 far as the same may be permitted to be done by corporations organized
4 under the General Business Corporation Law of the State of Idaho.

5 (7) To enter into any lawful arrangements for sharing profits,
6 union of interest, reciprocal concession, or cooperations, with any
7 corporation, association, partnership, syndicate, entity, person, or
8 governmental, municipal, or public authority, domestic or foreign, in
9 the carrying on of any business which the corporation is authorized to
10 carry on or any business or transaction deemed necessary, convenient
11 or incidental to carrying out of any of the purposes of the corporation.

12 (8) To enter into and make all necessary contracts for its
13 business with any person, entity, partnership, association, corporation,
14 domestic, or foreign, or of any domestic or foreign state, government
15 or governmental authority, or of any political, or administrative sub-
16 division, or department thereof, and to perform and carry out, assign,
17 cancel, or rescind any such contracts.

18 (9) To exercise all or any of the corporate powers and to
19 carry out all or any of the purposes, enumerated herein or otherwise
20 granted or permitted by law, while acting as agent, nominee, or
21 attorney in fact for any persons or corporations, and to perform any
22 service under contract or otherwise for any corporation, joint stock
23 company, association, partnership, firm, syndicate, individual, or other
24 entity, and in such capacity or under such arrangement, to develop,
25 improve, stabilize, strengthen, or extend the property and commercial
26 interests thereof, and to aid, assist, or participate in any lawful
27 enterprises in connection therewith or incidental to such agency,
28 representation, or service, and to render any other service or
29 assistance in so far as it lawfully may under the General Business
30 Corporation Law of Idaho.

31 (10) To do everything necessary, proper, advisable, or
32 convenient for the accomplishment of any of the purposes, or the

1 attainment of any of the objects, or the furtherance of any of the powers
2 herein set forth, either alone or associated with others, and incidental
3 or pertaining to, or growing out of, or connected with, its business or
4 powers, provided the same be not inconsistent with the laws of the State
5 of Idaho.

6 Nothing herein contained shall be deemed or construed as
7 authorizing, or permitting or purporting to authorize or permit the corporation
8 to carry on any business, exercise any power, or do any act which the
9 corporation may not, under the General Business Corporation Law, lawfully
10 carry on, exercise, or do.

11 The provisions in the clauses contained in this Article are to be
12 construed both as purposes and powers and shall, except when otherwise
13 expressed in this Article, be in no wise limited or restricted by reference
14 to or inference from the terms of any other clause of this, or any other,
15 Article of these Articles of Incorporation, but each of the purposes and
16 powers specified in this Article shall be regarded as independent purposes
17 and powers; and the specification herein contained of particular powers is
18 not intended to be, and shall not be held to be, in limitation of the general
19 powers herein contained, or in limitation of the powers granted to corporations
20 under the laws of the State of Idaho, but is intended to be, and shall be held
21 to be, in furtherance thereof.

22 III.

23 That this corporation shall have perpetual existence.

24 IV.

25 That the registered office of this corporation in the State of
26 Idaho shall be located in Twin Falls, Idaho, in the County of Twin Falls,
27 and that the post office address of said registered office shall be Twin Falls,
28 Idaho 83301.

29 V.

30 That the authorized capital stock of this corporation shall be
31 \$250,000.00, divided into 2,500 shares of a par value of \$100.00 each, and

1 that the total authorized number of shares shall be 2,500 and their total
2 par value shall be \$250,000.00. No share of stock of this corporation when
3 issued and fully paid for shall be subject to assessment.

5 That the amount of capital stock of this corporation which has
