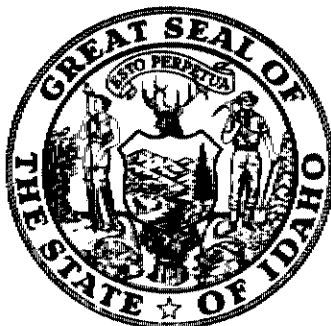

**ARTICLES OF INCORPORATION  
JOINT VENTURE LAND COMPANY, INC.**

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

- FIRST**      The name of the corporation is **JOINT VENTURE LAND COMPANY, INC.**
- SECOND**     The period of its duration is perpetual.
- THIRD**      The purpose or purposes for which the corporation is organized are: The transaction of a business and any or all other lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.
- FOURTH**    The aggregate number of shares which the corporation shall have authority to issue is 100,000. The shares shall have no par value.
- FIFTH**      The address of the initial registered office of the corporation is 2322 N. 8th, Coeur d'Alene, ID 83814, and the name and address of its initial registered agent is Michael P. Bale at the same address.
