

As set forth by the State of Idaho the following defines the incorporation of Bazzoli-Fleenor Dist., Inc. as a corporation doing business in the city of Boise, in the county of Ada, in the state of Idaho:

Articles of Incorporation set forth according to 30-1-54 (1):

- (a) The name of the corporation: Bazzoli-Fleenor Dist., Inc..
- (b) The duration of this corporation is perpetual.
- (c) The purpose of this business is to manufacture and distribute the highest quality of micro-brewed beer, and create ever increasing profits.
- (d) The corporation is authorized to issue 1,000,000 shares of common stock with a par value of \$1.00 in accordance with section 30-1-61 and sections 30-1-15 thru 30-1-26.
- (e) There will be no division of stock by class.
- (f) There will be no issuances of preferred or special class in series.
- (g) No preemptive rights will be denied.
- (h) The incorporators will not set forth any special provisions, with regards to the regulation of internal affairs of the corporation, including any provisions restricting the transfer of shares.
