ARTICLES OF INCORPORATION

OF

EASTERN IDAHO PAINT HORSE CLUB, THE CETYED STATE

ARTICLE I

91 OCT 36 AM 2 31

NAME

The name of the corporation (hereinafter called the corporation) is EASTERN IDAHO PAINT HORSE CLUB, INC.

ARTICLE II

This corporation is a non-profit corporation organized pursuant to the General Corporation Laws of the State of Idaho.

ARTICLE IV

PURPOSE AND POWERS OF THE CORPORATION

ARTICLE VI

MEMBERSHIP

This corporation shall have members and the management of itis: affairs is to be vested in its members pursuant to section 30-314(c) Idaho Code.
