ARTICLES OF INCORPORATION

OF

PAIAPA HOMEFURNISHERS, INC.

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned incorporators, all being residents of Canyon County, State of Idaho, do hereby certify that we have this day voluntarily associated ourselves together for the purpose of forming a corporation under and in compliance with the laws of the State of Idaho, and do hereby adopt the following ARTICLES OF INCORPORATION, to-wit:

ARTICLE I.

The name of this corporation shall be and is "PAIAPA HOMEFURNISHERS, INC."

ARTICLE II.

The purposes for which this corporation is formed are the following:

(a) To engage both wholesale and retail in the business of buying, selling and dealing with home, office and building furnishings, fixtures, and equipment, and furnishings, fixtures and equipment of any type or kind.

(b) To buy, sell, deal in, install, repair, and to conduct all types of business enterprises concerning floor coverings, all related products thereto, and all supplies used in connection therewith, for homes, offices, businesses and structures of any type or kind.

(c) To engage both retail and wholesale in the business of buying, selling and dealing with goods, wares and merchandise of any type or kind.

(d) To buy, sell, own, hold, lease, improve and deal in real estate or personal property of any type and description, other

or not the same is used in connection with any of the purposes of the corporation listed herein.

(e) To acquire, own, hold, lease, build and/or erect any and all buildings, structures and plants that may be deemed suitable to the furtherance of the foregoing or any purposes for which the corporation is formed, and to operate, manage, control, rent, sell or otherwise dispose of the same.

(f) To incur indebtedness in such amount as may be deemed necessary, and to borrow money to evidence such or any indebtedness or the issue of other written obligations of the corporation; and to secure the same by mortgage, deed of trust, or other form of encumbrance upon all or any part of any property, real or personal, of the corporation, whether owned or to be acquired or after death to be received.

(g) To carry on any activity or activities that might be related to any of the above described powers of the said corporation.

(h) To do such business not only within the State of Idaho, but in any part of the world, as may be deemed and determined by and agreed of directors from time to time, without limiting any of the objects and purposes aforesaid. It is expressly declared that the corporation shall have and possess all the powers specifically hereinabove enumerated, and also any and all such additional or further powers as may be incidental to the carrying out of the same, and also such other rights, privileges and powers granted by the laws of this state to corporations, except such as may be inconsistent herewith; the intention hereof is expressly declared to be that the powers of this corporation as expressed herein shall be construed as a grant of general powers and not in any sense as a grant of special or limited powers.

(i) To acquire, invest in, own and dispose of the capital stock of this corporation and of other corporations, and the business property and assets of any person, copartnership or corporation.

ARTICLE III.

The principal place of business and the place where the principal office of the corporation shall be is hereby designated as the City of Nampa, Canyon County, Idaho.

ARTICLE IV.

The existence of the corporation shall be perpetual.

ARTICLE V.

The number of directors of this corporation is hereby fixed at three.

ARTICLE VI.

The capital stock of this corporation shall be One hundred Thousand Dollars, to be divided into 1,000 shares of the par value of \$100.00 per share.

ARTICLE VII.

The amount of capital stock actually subscribed is the sum of \$300.00, and the same has been subscribed by the persons whose names hereto appear as incorporators, and they have subscribed to the following shares: M. E. Rossman, one share, 673 6th Street South, Nampa, Idaho; Elizabeth Rossman, one share, 603 6th Street South, Nampa, Idaho; Carl T. Kelley, one share, 619 11th Avenue South, Nampa, Idaho; each of whom is of full age and a citizen of the United States of America.


