

Articles of Incorporation
of
The S. W. Coffin Commercial Company,
Limited.

Know all men to these Presents: That we, the undersigned, have voluntarily associated ourselves together for the purpose of forming a private Corporation, under and in virtue of the Laws of the State of Idaho; and we do hereby set forth and declare as follows, to wit:

First. That the name of such Corporation is and shall be when so formed, "The S. W. Coffin Commercial Company, Limited."

Second. That the place where the principal business of the Corporation is to be transacted is the town of Caldwell, in the County of Ada, State of Idaho.

Third. That the term for which said Corporation shall exist is forty 100 years.

Fourth. That the purposes for which said Corporation is formed, are, The purchasing, owning and selling of hardware, agricultural implements, machinery of various kinds, groceries and general supplies;

The procuring, handling and selling on commission of goods belonging to either or all of said classes or lines, the buying and selling of Hay, grain and Farm products, The conducting of wholesale and retail, hardware, implement, grocery and supplies stores, The pur-

chasing, constructing, owning, selling and leasing
of such building or buildings, and the acquir-
ing, purchasing, owning, leasing and selling of
such real estate, as may be required to best pro-
mote the business of said corporation; —

And the doing and performing of all such
other acts and things, as may be incident to
the most full and complete carrying out of
the purposes above set forth, —
