### CERTIFICATE OF AMENDMENT OF ARTICLES OF INCORPORATION

I, ARNOLD WILLIAMS, Secretary of State of the State of Idaho, and legal custodian of the corporation records of the State of Idaho, do hereby certify that the

a corporation organized and existing under and by virtue of the laws of the State of Idaho, filed in this office on the **13th** day of **June** 19 **60**, original articles of amendment, as provided by Section **30-146 and 30-147, Idaho Code,** changing corporate name to **IDAHO-OREGON FRUIT GROWERS, INC.,**

and that the said articles of amendment contain the statement of facts required by law, and are recorded on Film No. **112** of Record of Domestic Corporations of the State of Idaho.

AMENDMENT TO THE ARTICLES OF INCORPORATION

of

FRUITLAND COOPERATIVE, INC.

Adopted

June 1, 1960

ARTICLE I of the Articles of Incorporation of the Fruitland Cooperative, Inc., shall be amended to read as follows:

ARTICLE I

The name of this association shall be and is:

IDAHO-OREGON FRUIT GROWERS, INC.

CERTIFICATE OF AMENDMENT

We, Ralph Garman and Horace Brown, being each first duly sworn, according to law, severally depose and say:

That at all times herein mentioned they were and now are respectively the President and Secretary of Fruitland Cooperative, Inc., a cooperative marketing association organized under the Cooperative Marketing Act of the State of Idaho.

That the foregoing amendment to the Articles of Incorporation of Fruitland Cooperative, Inc., was first approved by the affirmative vote of more than two-thirds of the members of the Board of Directors of said association, to-wit, by the affirmative vote of all of said members at a meeting of said Board of Directors duly held and convened on the 16th day of February, 1960, at which meeting more than a quorum, to-wit, all of said Board of Directors were present in person at all times; and that subsequently said amendment to the Articles of Incorporation was adopted by the affirmative vote of more than two-thirds of the members of Fruitland Cooperative, Inc., duly noticed, held and convened on the First day of June, 1960, at which meeting there were present in person more than a quorum as required by the By-Laws of said Association.

That thereafter triplicate originals of said Amendment to the Articles of Incorporation, so adopted, were prepared and were signed and sworn to by the President and Secretary of said association.
