

ARTICLES OF INCORPORATION

OF

CASH DISCOUNT CLUB, INC.

WE, the undersigned natural persons of the age of twenty one years or more, acting as incorporators of a corporation under the Colorado Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is CASH DISCOUNT CLUB, INC.

SECOND: The period of its duration is perpetual.

THIRD: The purposes for which the corporation is organized are:

To transact the business of promoting and developing the business of other corporations, partnerships, or individuals for hire, or upon commission, or otherwise, by and through the promotion in newspapers, books, booklets, prospectuses, magazines, circulars, pamphlets, or other similar literature and advertising media, the sale to the consuming public of membership cards, entitling the holders thereof to a cash discount on purchases made at members stores, said member stores being either corporation, partnerships, or individuals, entitled to display the emblem of active participation in said promotion and development by payment of a fee, or upon commission, or otherwise, and further of promoting the business, commodities, or other property, real, personal, or mixed, of member corporations, partnerships, or individuals in newspapers, books, booklets, prospectuses, magazines, circulars, pamphlets, or other similar literature and advertising media.

To manufacture, purchase, or otherwise acquire, own, mortgage, pledge, sell, assign and transfer, or otherwise dispose of, to invest, trade, deal in and deal with, goods, wares, and merchandise and real and personal property of every class and description.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 49,999 shares of common stock at par value of \$1.00 each.

 $\mbox{FIFTH:}$ Cumulative voting of shares of stock is authorized.

SIXTH: Provisions limiting or denying to shareholders the preemptive right to acquire additional or treasury shares of the corporation is authorized to stockholders and shall be offered at par, pro rata, to the common stockholders in relation to their holdings.
