

ARTICLES OF INCORPORATION  
OF

NEW DAY PRODUCTS, INC.

KNOW ALL TO WHOM THESE PRESENTS MAY COME:

That we, whose names are hereunto subscribed, all of whom are citizens of the United States of America and bona fide residents of the State of Idaho, and each of us being of full legal age, do under and pursuant to the General Corporation Laws of the State of Idaho, associate ourselves together for the purpose of becoming a body corporate, and do now declare these as the articles of incorporation of NEW DAY PRODUCTS, INC., a corporation.

ARTICLE I

The name of this corporation shall be:

NEW DAY PRODUCTS, INC.

ARTICLE II

The purposes for which this corporation is formed are:

1. To provide vocational development services, including vocational evaluation, vocational adjustment, work experience and extended controlled employment for vocationally handicapped persons.
2. To sub-contract with other firms and agencies for work for the handicapped.
3. To enter into any and all agreements which may be necessary to perform the above services for the handicapped.
4. Prevocation training services to be performed in the work shop and the performing of all services needed to carry out this service.
5. For the Supervised living in residential housing for the handicapped.
6. For the signing of any agreements and contracts which may be necessary in carrying out the above purposes.
7. To purchase, rent, or otherwise acquire personal and real property of every kind and description within and without the State of Idaho which may be necessary to fulfil the above services.
8. To borrow money and give security therefor in the purchase of or acquisition of property of every nature and kind in connection with said services.

This is a benevolent and charitable corporation for the sole purpose of assisting the vocationally handicapped persons of Southeastern Idaho, namely, in the following counties:

Bingham, Power, Bannock, Bear Lake,  
Caribou, Franklin, Oneida.

### ARTICLE III

The principal place of business of said Corporation shall be 928 N. Main, Pocatello, Idaho.

### ARTICLE IV

The term for which this Corporation shall exist shall be perpetual.

### ARTICLE V

The corporate power and business shall be exercised and controlled by a Board of three Directors and not more than thirteen directors.

### ARTICLE VI

There will be no capital stock or membership certificates. This is strictly a benevolent and charitable corporation and any excess funds accumulated will be utilized for expansion and improvement of services.

### ARTICLE VII

The corporation will be operated by a Director chosen by the Board of Directors, the number of directors shall be not less than three and no more than thirteen.

### ARTICLE VIII

A meeting was held on August 29, 1972, at 11:30 A. M. at 928 N. Main, Pocatello, Idaho, and officers were elected for the corporation and prior thereto Notice was published in the Idaho State Journal on August 14, 1972, and August 21, 1972, and a copy of said Notice was posted on the building where

the election was to be held, all pursuant to Section 30-1102,  
Idaho Code.
