ARTICLE I

The name of the Corporation is R.C. CONSTRUCTION, INC.

ARTICLE II

The period of duration of the Corporation is perpetual.

ARTICLE III

This Corporation shall have unlimited power and purpose to engage in and to do any lawful act concerning any of all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act, as amended, under the provisions of which this Corporation is incorporated.

ARTICLE IV

1. The aggregate number of shares which this Corporation shall have authority to issue is 100 shares.
2. Such shares are to consist of one (1) class only, to be known as common stock, and such shares are to have no par value.
3. Corporation shall have the right to purchase it's own shares from the unreserved and unrestricted capital surplus available, as well as from the unreserved and unrestricted earned surplus available.
4. Said common stock qualified under Section 1244 of the Internal Revenue Code, as

amended, and shall be and hereby is "1244" stock.

ARTICLE V

ARTICLE VI

ARTICLE VII

Thereafter, such number shall not be less than one (1) as may from time to time be specified in the Bylaws.
