

ARTICLES OF INCORPORATION OF R.C. CONSTRUCTION, INC.

ELIZABETH IRENE COOK, who is over eighteen (18) years of age, acting as incorporate of a corporation under the laws of the State of Idaho, adopts the following ARTICLES OF INCORPORATION for such Corporation:

ARTICLE I

The name of the Corporation is R.C. CONSTRUCTION, INC.

ARTICLE II

The period of duration of the Corporation is perpetual.

ARTICLE III

This Corporation shall have unlimited power and purpose to engage in and to do any lawful act concerning any of all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act, as amended, under the provisions of which this Corporation is incorporated.

ARTICLE IV

- 1. The aggregate number of shares which this Corporation shall have authority to issue is 100 shares.
