

CERTIFICATE OF CORRECTION OF

BOISE CASCADE CORPORATION

(to correct an error in the certificate of agreement of merger of Ebasco Industries Inc. with and into Boise Cascade Corporation filed in the office of the Secretary of State of Delaware on August 19, 1969 and recorded in the office of the Recorder of Deeds for New Castle County, Delaware on August 19, 1969)

Boise Cascade Corporation, a corporation organized and existing under and by virtue of The General Corporation Law of the State of Delaware, DOES HEREBY CERTIFY THAT:

1. The name of the corporation is Boise Cascade Corporation.

2. A certificate of agreement of merger of Ebasco Industries Inc. with and into Boise Cascade Corporation was filed by the Secretary of State of Delaware on August 19, 1969 and recorded in the office of the Recorder of Deeds of New Castle County on August 19, 1969 and the said certificate of agreement of merger requires correction as permitted by subsection (f) of section 103 of The General Corporation Law of the State of Delaware.

3. The inaccuracy or defect of the said certificate of agreement of merger to be corrected is as follows: subsection 4.1 of ARTICLE FOURTH of appendix I thereof (which appendix sets forth the restated certificate of incorporation of Boise Cascade Corporation) states that

"4.1 Designation and amount. The first series of Preferred Stock shall consist of (83,524) shares and the designation of such series shall be "\$3.00 Cumulative Convertible Preferred Stock, Series A" (the "Series A Preferred Stock")."

whereas in fact the first series of Preferred Stock consists of eighty-five thousand four hundred eighty-five (85,485) shares.

4. Subsection 4.1 of ARTICLE FOURTH of appendix I of the said certificate of agreement of merger is corrected to read as follows:

"4.1 Designation and amount. The first series of Preferred Stock shall consist of eighty-five thousand four hundred eighty-five (85,485) shares and the designation of such series shall be "\$3.00 Cumulative Convertible Preferred Stock, Series A" (the "Series A Preferred Stock")."
