ARTICLES OF INCORPORATION

OF

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, 91 NOV 25 AT 10 48 incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST

The name of the corporation is Rocky Mountain Power Craft, Inc.

SECOND

The period of its duration is perpetual.

THIRD

The purpose or purposes for which the corporation is organized are: For the sale, promotion, advertisement and distribution of Parascenders and the retail marketing of such equipment as well as any other product, and all other things incidental thereto necessary to conduct business, together with the transaction of all other lawful business for which corporations may be incorporated under the Idaho Business Corporation Act, Section 30-1-3.

FOURTH

The aggregate number of shares which the corporation shall have authority to issue is 5,000 shares of \$1.00 par value common stock.

<u>FIFTH</u>

Shareholders shall have full pre-emptive rights.
