**Articles of Incorporation
(Non-Profit)**

The undersigned, in order to form a Non-Profit Corporation under the provisions of Title 30, Chapter 3, Idaho Code, submits the following articles of incorporation to the Secretary of State.

Article 1: The name of the corporation shall be BIG CEDAR COMMUNITY CENTER, INC.

Article 2: The purpose for which this corporation is organized is: To provide involvement in community life for people of all age groups within the Kooskia area; to provide a centralized meeting place where youth groups, senior citizens and all civic minded organizations can meet and conduct their business; to provide social, recreational and educational facilities on a non-sectarian and non-partisan basis where people can meet, help each other and better their community; to do and transact any and all business necessary and expedient for carrying out the purpose for which this corporation is formed; to enter into agreements, contracts, purchases, sales and other agreements relating to real and personal property not prohibited by law, necessary and expedient for the purposes of this corporation; to hold real and personal property; and to do anything not prohibited by law, necessary or requisite for the furthering of the purpose of this corporation.

Article 3: The street address of the registered office shall be Big Cedar Community Center, Inc., Rt. 1 Box 86, Kooskia, Idaho 83539.

The registered agent of the incorporation is Jean Ulmer, Rt. 1 Box 86, Kooskia, Idaho 83539.

The members of this corporation shall not be subject to assessment for the purpose of paying expenses, conducting business or paying debts of the corporation. Membership in the corporation shall not entitle a person to any interest in the assets of the corporation, but only to participate in the management of the affairs of the corporation through meetings of the members legally called by the membership.

Article 8: At the dissolution of the corporation, any assets remaining shall be given to some charitable organization designated by the membership.
