AMENDMENT TO
CERTIFICATE OF LIMITED PARTNERSHIP **SECRETARY OF STATE**

THIS AMENDMENT TO CERTIFICATE OF LIMITED PARTNERSHIP with respect to HILLVIEW RANCH ASSOCIATES, an Idaho Limited Partnership, is executed in accordance with the requirements of Section 53-209, Idaho Code, and amends that certain Certificate of Limited Partnership filed May 12, 1983.

1. Section 4 of the Amended Certificate of Limited Partnership is hereby amended to read as follows:

9. The share of net profits or the other net compensation by way of income to which each limited partner shall be entitled (based upon the entire net profits and net income of the partnership as being 100 units) is:

A limited partner shall not receive compensation or income from the partnership other than the share of net profits of the partnership above set forth.

2. With the exception of the foregoing amendment, the Certificate of Limited Partnership remains unchanged.




