ARTICLES OF INCORPORATION
of the
RECREATIONAL CUTTING CLUB.

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, being of lawful age, and citizens of the United States of America, and of the State of Washington, for ourselves, our associates and successors, have associated ourselves together for the purpose of forming a corporation under and by virtue of the laws of the State of Washington, and we do certify and declare as follows, to wit:

I.

That the name of the said corporation shall be the "RECREATIONAL CUTTING CLUB."

II.

The objects and purposes for which this corporation is formed are as follows:

To acquire by purchase, lease, own, build, sell, mortgage or encumber both improved or unimproved real estate, wherever situated; to survey, subdivide, plat, and improve the same for the purposes of sale or otherwise; also, to construct, erect and operate thereon houses, buildings, light and power plants, machinery and appliances for such plants; to erect, construct, operate and maintain telephone lines; to construct, purchase, lease or otherwise acquire, maintain, operate and sell water works for the purpose of supplying corporations and individuals with water for domestic and business uses; to construct, purchase, lease or otherwise acquire, maintain and sell all necessary power houses, water tanks, water mains and pipes convenient for the carrying on of the aforesaid water business. To buy, lease or otherwise acquire, construct, maintain and operate steamboats and

other vessels of any class; to carry on the business of port agency, and to enter into contracts for the carriage of mail, passengers, goods and merchandise, by any means; to buy, lease or otherwise acquire, construct, maintain and operate wharves, piers, docks, warehouses and depots; to design, construct and repair vessels, ships, boats, wharves, docks, dry docks and piers. To buy, lease or otherwise acquire, construct, maintain, operate and equip railroads and street railways to be operated by steam, electricity or other power.

III.

The amount of the capital stock of this corporation shall be Sixteen Thousand Dollars (\$16,000), divided into eighty (80) shares of the par value of Two Hundred Dollars (\$200) each.

IV.

The term for which this corporation shall exist is forty (40) years.

V.

The number of trustees of this corporation shall be seven (7), and the names and places of residence of those who are to manage the concerns of the corporation for the first six (6) months are as follows:
