#### ARTICLES OF INCORPORATION

Dated: April 15, 1991

BE IT KNOWN That We, the undersigned, being natural persons of full age and citizens of the United States, in order to form a corporation for the purposes hereinafter stated, under and pursuant to the provisions of the general corporation laws of the State of Idaho, and in particular Chapter 3 of Title 30, and the Acts amendatory thereof and supplemental thereto, do hereby associate ourselves, together with such other persons as may

ARTICLE I.

associate themselves and their successors, for the purpose of

NAME

The name of this corporation is "The National Doctor of Arts Association, Inc.," a nonprofit corporation.

ARTICLE II.

PERIOD OF DURATION

The period of duration is perpetual.

ARTICLE III.

**PURPOSES** 

This nonprofit corporation is generally educational with these supplemental purposes:

- A. To foster visibility, credibility, and quality of the Doctor of Arts degree in the United States.
- B. To provide communications among and between Doctor of Arts students, DA and other doctoral degree holders, educational institutions granting the DA degree, educational institutions considering granting the DA degree, and private and public entities which find the DA degree to be valuable for their employees and themselves.
- C. To be a mechanism to foster solidarity among students working towards the DA degree, DA and other doctoral degree holders, and institutions granting the DA degree.
- D. To be a source of counsel and developer of criteria to maintain and enhance the scholarship content and professionalism of the DA degree.
- E. To work for the professional placement and advancement of DA degree holders.
- F. To create a climate which will lead to obtaining funds to carry out the foregoing purposes and additionally to disburse funds in the form of scholarships, fellowships, and grants to qualified DA students and/or institutions granting the DA.

#### ARTICLE IV.

#### MEMBERS AND MANAGEMENT

A. There will be four classes of dues-paying members: DA students; individual doctoral degree holders; educational institutions granting the DA degree; and temporary, non-voting institutional members considering granting the DA degree. Dues may be assessed differently among these four classes. There will



be two classes of non-dues-paying members: Honorary and Benefactor.

B. Management will be by a Board of Directors subsequently elected from the membership. The Board of Directors shall elect from its membership officers and appoint an Executive Director to run the day-to-day affairs of the corporation, except that initially the organizers of the corporation, whose names and addresses appear below, will undertake the functions of the Board of Directors.

#### ARTICLE V.

#### COUNCIL OF BENEFACTORS

The corporation shall have a Council of Benefactors which shall be unlimited in number. Members of the Council shall serve without compensation and without requirements for duties or responsibilities of any kind. The qualifications and method of selection of the Benefactors shall be as specified in the Bylaws.

#### ARTICLE VI.

### STREET ADDRESS OF INITIAL REGISTERED OFFICE AND AGENT

#### ARTICLE VII.

#### AMENDMENTS

These Articles of Incorporation may be amended at any time in the manner and form provided by the Idaho Code as existing at the time of the adoption of these Articles of Incorporation or as provided by any other applicable law, but no amendment may be adopted which changes or affects in any way the exempt status of the corporation as an organization existing exclusively for educational, literary, scientific, or humanistic purposes.
