In reference to our telephone conversation this a.m. for the Articles of Organization Limited Liability Company for the above captioned client, you requested this letter to clarify the position of the company's corporation and the request to form the new LLC.

Carl Pitts & Sons Well Drilling, Inc. consisted of the father and two sons. The father effective September 1, 2000 has sold his interest in the business to the sons. At which time (9-01-00) the corporation ceased operating.

The application for the Limited Liability Company is to create the new entity effective September 1, 2000. This will be owned by the two sons as member/managers.

The corporation will be dissolved effective September 1, 2000 with the exception of filing the final tax return which cannot be completed since the forms are not available. This return is due by March 15, 2001. It will, however, reflect income and expenses for the period January 1, 2000 through August 31, 2000.

This should allow the State to authorize the formation of the Limited Liability Company since the corporate name, which is so close, will cease being used as of September 1, 2000.
