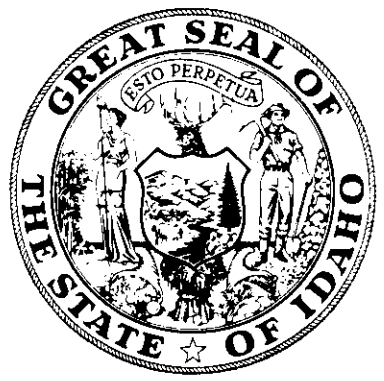

provisions of the Articles of Incorporation, or, if none, among its shareholders, in accordance with their respective rights and interests.

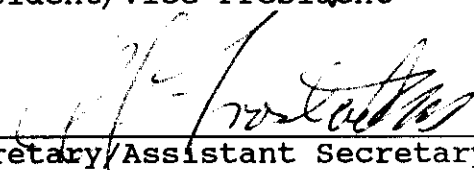
