ARTICLES OF INCORPORATION of WILD HORSE PUBLISHING COMPANY



KNOW ALL MEN BY THESE PRESENTS that we, the undersigned, being studied persons of full age and at least two thirds of them being citizens of the dited States, in order to form a corporation for the purposes hereinafter states, pursuant to the Business Corporation Act of Idaho, do hereby certify pursuant to the Business Corporation Act of Idaho, do hereby certify the follows:

ARTICLE I.

The name of this corporation shall be "Wild Horse Publishing Company."

ARTICLE II.

The business pursuits of this corporation and the purposes for which it was organized are as follows:

- 1. To print, publish, and sell books, newspapers, journals, magazines, periodicals, lists, pamphlets, and reports for the dissemination of current and general architectural, engineering, construction and building trade news, notices, and information, throughout the business world.
- 2. To carry on the business of printers, engravers, publishers, book and print sellers, bookbinders, and art journalists in all their branches; to carry on the business of newspaper and magazine proprietors, news agents, journalists, literature agents, and stationers in all their branches; to carry on the businesses of manufacturers and distributors of and dealers in engravings, prints, pictures, drawings, and any written, engraved, painted, or printed productions, in all their branches.
- 3. To carry on the business of stationers, printers, lithographers, stereotypers, electrotypers, photographic printers, photolithographers, engravers, diesinkers, book printers, account book manufacturers, designers,

draftsmen, ink manufacturers, book sellers, publishers, paper manufacturers, and dealers in or manufacturers of any other article or things of a character similar, analogous to the foregoing, or any of them, on connected therewith.

- 4. To engage in the operation of news services and news gathering agencies of all types and nature, and in connection therewith to participate in wire services and other types of communication of news and information for newspapers and other periodicals and users of such services.
- 5. To acquire by purchase or otherwise to own, hold, manage, buy, sell, convey, lease, encumber and generally to deal in and with real property and all interests therein not only as owner but also as agent, broker or otherwise.
- 6. To purchase, acquire, own, hold, mortgage, pledge, sell, transfer, encumber and in any other manner to dispose of, deal and trade in goods, wares, merchandise, and personal property of every class and description whether at wholesale, retail or otherwise.
- 7. To loan money upon notes, bonds, stock or any other evidences of indebtedness.
- 8. To borrow money for the business of the company and to give security therefor, and in pursuance of the business of the company to issue bonds, debentures, promissory notes or other evidences of indebtedness, and to secure the same by mortgage or pledge of all or any part of the property of the company, real or personal.
- 9. To enter into and make, perform and carry out contracts of every kind and description made for any lawful purpose, without limit as to amount, with any person, firm, association, or corporation either public or private, or with any municipality, county, state, territory, colony, province, nation, government, or agency or subdivision thereof.
- 10. To purchase or otherwise acquire the whole or any part of the assets, business, good will or right of any person, firm, association,

corporation or organization and to assume and undertake the whole or any part of the obligation thereof.

- 11. To own and hold stock in other corporations, to establish, form, subsidize or otherwise assist in the establishment, organization of formation of other companies, firm or corporations; to own, hold, sell, negotiate, assign, deal in and exchange, transfer, mortgage, pledge, hypothecate and otherwise deal in and dispose of any shares of the capital stock, bonds, notes, debentures, mortgages, securities and other evidences of indebtedness issued or created by any other corporation.
- 12. To do generally any and all things which the company may deem necessary, proper and convenient in its said business for the improvement and use of the corporation property, and in carrying out and accomplishing the purposes hereinbefore specified, and in addition thereto to have all the general powers granted to corporations by virtue of the laws of the State of Idaho.

ARTICLE IV.

The principal place of business and the registered office of this corporation shall be at 13729 Lake Avenue, Nampa, Canyon County, Idaho. 83651. The registered agent at this address shall be Earl L. Maggard.

ARTICLE V.

The existence of this corporation is to be perpetual.

ARTICLE VI.

The capital stock of this corporation shall consist of two hundred fifty thousand dollars (\$250,000) divided into five hundred (500) shares of preferred stock, with a par value of one hundred (\$100.00) per share, and two thousand (2,000) shares of common stock with a par value of One Hundred Dollars (\$100.00) per share.

That the capital stock issued and outstanding consists of: preferred stock - none; common stock - one thousand (1,000) shares.

Each share shall be entitled to one vote at any regular or special shareholders' meeting.

The Board of Directors have the authority to divide any or all stock classes into series and fix and determine the relative rights and preferences of the shares of any series established.

The initial capital with which this corporation shall commence business shall be the sum of One Thousand Dollars (\$1,000.00).

ARTICLE VII.

The number of directors of this corporation shall at the commencement of business be three (3), but the Board of Directors may at any time, by amendment of the By-Laws, be increased to any number not exceeding nine (9) or decreased to any number not less than (3).
