# ARTICLES OF INCORPORATION OF SODA SPRINGS HOPE LUTHERAN CHURCH, INC.

KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned, have this day voluntarily associated ourselves together for the purpose of forming a non-profit corporation under Title 30 of the Idaho Code, and we certify:

# ARTICLE I

The name of the corporation shall be SODA SPRINGS HOPE LUTHERAN CHURCH, INC., an Idaho corporation.

## ARTICLE II

Said corporation shall be a non-profit corporation.

### ARTICLE III

The time duration of said corporation shall be perpetual.

## ARTICLE IV

That the purposes for which this corporation is formed are as follows:

To provide for the promotion, support, maintenance and establishment
at Soda Springs, Caribou County, State of Idaho, of an Evangelical Lutheran
Church and to provide a place of public worship for the same; to support
the doctrine and be subject to the laws, usages and ministeral appointment
of such an Evangelical Lutheran Church as from time to time established,
made and declared by the lawful authority of said church; to establish,
maintain and conduct schools for the religious instruction of the young,
and to further other religious and charitable work, and to that end may
adopt and establish by-laws and make all rules and regulations deemed
necessary and expedient for the management of its affairs, in accordance
with the law and the laws and regulations of the Evangelical Lutheran Church
and which are not inconsistent with these Articles; to secure, hold, improve,
encumber, sell, convey, manage, and dispose of property, both real and
personal, in fee simple and otherwise.

#### ARTICLE V

Said corporation shall have members as set forth in the by-laws with each member having an equal share in the rights, preferences, privileges, and voting powers of the corporation.

#### ARTICLE VI

The directors of the corporation shall be the Church Council and shall be elected or organized as prescribed in the Church Constitution and/or by-laws of Soda Springs Hope Lutheran Church, subject always to the laws of the State of Idaho.

## ARTICLE VII

The office of said corporation is located at 164 South Main Street, Soda Springs, Idaho, with a mailing address of Box 831, Soda Springs, Idaho 83276. The initial registered agent of said corporation, located at said address, is Terry Rosenau.

## ARTICLE VIII

The names and addresses of the incorporators of said corporation, and of the persons who are to act as directors until the selection of their successors are:

The number of the persons above named shall constitute the number of directors of the corporation until changed by an admendment to the by-laws, increasing or decreasing the number of directors, as may be desired.

## ARTICLE IX

In the event of the dissolution of this corporation because the congregation which said corporation is formed to serve should totally disband, the property of the corporation and all rights connected therewith shall be transferred to the Northwest District of the Lutheran Church - Missouri Synod, or to such other tax exempt religious or charitable organization as may be determined by the congregation at the time of disbanding.
