ARTICLES OF INCORPORATION REEVES INVESTMENTS, INC.

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the Laws of the State of Idaho, and to that end do hereby execute these Articles of Incorporation:

ARTICLE I.

The name of the proposed corporation is REEVES INVESTMENTS, INC.,

ARTICLE II.

The purposes of the proposed corporation are:

- 1. To engage in buying, selling, renting, leasing or in any other manner acquiring or disposing of real property wherever it may be situated.
- 2. To engage in buying, selling, renting, leasing or in any other manner acquiring or disposing of all types of personal property wherever it may be situated, including but not limited to:
- a) All types of investment in the corporate shares of other corporations; to acquire corporate bond, debentures, notes, contract, or any other evidence of obligation, right, title or interest.

b)All types of Federal, State, County or Municipal bonds or other securities issued by the Federal Government, any State or political subdivision thereof including local improvement districts, specialized bonds or other such securities.

c) All types of franchises, licenses, patents or other authority to operate any type of wholesale, jobber or retail

saler, jobber or retail business. d) To manage, supervise, control or operate all types of real and personal property whether owned by this corporation or persons, firms or corporation. e) To render all types of professional or specialized services which the corporation or any of its officers may be licensed to perform by the laws of any State in which this corporation is authorized to transact business. f) To buy, build, rent, lease or otherwise acquire office, shop, storage or other premises in which to transact the businesses of this corporation and to equip the same as the needs of the corporation may require. g) To acquire inventories of all types of goods for sale, lease, rental or loan to others and for use in the affairs of this corporation. h) To apply for, maintain or otherwise acquire such licenses, permits, franchises or other authority to transact corporate business. i) To have all of the authority, power and abilities set forth in Section 30-114 (2), Idaho Code, as the same now exists.
