ARTICLES OF AMENDMENT

to the

ARTICLES OF INCORPORATION

of

DAHN BROTHERS, INC.

(changing its name to SENTRY AUTOMATIC SPRINKLER SOUTHWEST)

Pursuant to Section 16-10-57 of the Utah Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the corporation is Dahn Brothers, Inc., but will be amended herein to Sentry Automatic Sprinkler Southwest.

SECOND: The following amendment to the Articles of Incorporation was adopted by the shareholders of the corporation on March 20, 1981, in the manner prescribed by the Utah Business Corporation Act:

Article I is amended to read as follows:

ARTICLE I

The name of the corporation is SENTRY AUTOMATIC SPRINKLER SOUTHWEST.

THIRD: The number of shares of the corporation outstanding at the time of such adoption was 2,600 shares of common stock; and the number of shares entitled to vote thereon was 2,600 shares of common stock.

FOURTH: The number of shares voted for such amendment was 2,600 shares of common stock; and the number of shares voted against such amendment was none.
