Pursuant to the provisions of Section 30-1-61 of the Idaho Business Corporation Act, Double E Ranch, Inc., has adopted the following Articles of Amendment to its Articles of Incorporation:

I

The name of the corporation is Double E Ranch, Inc.

II

The following amendments of the Articles of Incorporation were adopted by the shareholders and directors of the corporation on June 30, 1981, in the manner prescribed by the Idaho Business Corporation Act:

Article FIRST of the Articles of Incorporation shall be amended to read as follows:

FIRST: The name of the corporation is Evans Brothers Construction, Inc.

III

The number of shares of the corporation outstanding at the time of such adoption was 214, and the number of shares entitled to vote thereon was 214.

IV

The number of shares voted for such amendment was 214, and the number of shares voted against such amendment was 0.
