
LEWISTON AUTO WRECKERS, INC.

ARTICLES OF INCORPORATION OF STATE OF LEWISTON AUTO WRECKERS, INC.

The undersigned incorporator, desiring to form a corporation pursuant to the provisions of the Idaho Business Corporation Act, adopts the following articles of incorporation:

ARTICLE I. The name of the corporation is Lewiston Auto Wreckers, $\mathcal{I}_{\mathcal{M}}$

ARTICLE II. The purposes of the corporation are to buy, sell, wreck, and repair vehicles and parts, and to engage in any or all lawful business for which corporations may be organized under the Idaho Business Corporation Act.

ARTICLE III. The period of duration of the corporation is perpetual.

ARTICLE IV. The address of the corporation's initial registered office in the State of Idaho is 1628 - 8th Street, City of Lewiston, County of Nez Perece, 83501. The name of the corporation's initial registered agent at such address is Michael D. Kelleher.

ARTICLE V. The total authorized number of par value shares of stock is -0- dollars. The total authorized number of shares without par value is 100.

ARTICLE VI. There are no classes of stock. All stock is no par. All stock has equal voting power. There are no preemptive rights for stock purchasers.
