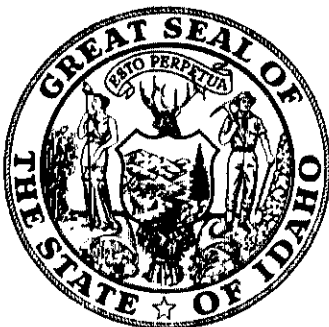
### CERTIFICATE OF INCORPORATION OF

**ARTICLES OF INCORPORATION**

The undersigned, acting as incorporator of a nonprofit Corporation under the Idaho Nonprofit Corporations Act, adopts the following Articles of Incorporation.

**FIRST:** The name of the Corporation is The Brooten-Butterfield Peace & Justice Center, Inc.

**SECOND:** The period of its duration is perpetual.

**THIRD:** The purposes for which the Corporation is organized is to promote peace and justice among all people.

**FORTH:** The Corporation shall have one class of membership. The bylaws shall establish the criteria and procedures for admission of members

**FIFTH:** The affairs of the Corporation shall be managed by a Board of Directors of not fewer than three (3) nor more than nine (9), for a term and in a manner as prescribed by the bylaws.

**SIXTH:** The annual meeting of the Corporation shall be held in a time and place prescribed by the bylaws.

**SEVENTH:** The officers of the Corporation shall consist of a president, a vice president, a secretary, a treasurer, each of whom shall be appointed by the Board of Directors.

**EIGHTH:** The initial Board of Directors shall be;

**NINTH:** Upon dissolution, the Corporation shall transfer its assets to one (1) or more persons described in section 501 (c)(3) of the Internal Revenue Code.

**ELEVENTH:** The incorporator of The Brooten-Butterfield Peace & Justice Center is Karen Mello, 1005 N. 6th, Coeur d'Alene, ID 83854.
