NAME

1. The name of the corporation is IDAHO TIMBER MANAGEMENT, INC.

DURATION

2. The period of it's duration is perpetual.

PURPOSE

3. The purpose or purposes for which this corporation is formed are as follows:

- (a) The purpose of IDAHO TIMBER MANAGEMENT, Inc., shall be to engage in the business of cutting and removal of timber and timber products and/or the business of holding, owning, maintaining, managing, improving, developing, operating, selling, transferring, conveying, leasing mortgaging, exchanging, or otherwise disposing of or dealing with or in real property, or dealing with or otherwise dealing in any other necessary, lawful, and proper business enterprise, under the designation, name and style of IDAHO TIMBER MANAGEMENT, Inc.; and to perform any acts to accomplish the foregoing purposes; and


