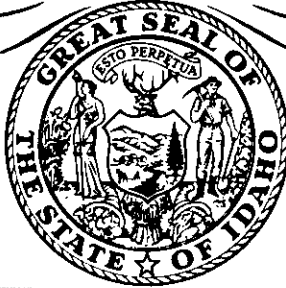

ARTICLES OF INCORPORATION

OF

CCA PATROL, INC.

KNOW ALL PERSONS TO WHOM THESE PRESENTS COME:

THAT WE, the undersigned, being citizens of the United States of America and of lawful age, for the purpose of forming a non-profit corporation pursuant to Chapter 1, Title 30, Section 117A of the Idaho Code, and for the purposes stated herein, do hereby adopt the following Articles of Incorporation:

ARTICLE I

The name of this corporation shall be the CCA PATROL, INC.

ARTICLE II

The address and place of business of this corporation is as follows:

Address: CCA PATROL, INC., Grimes-Mores Creek, c/o Idaho City

Stage, Boise, Idaho 83706

ARTICLE III

The corporation is organized for the purpose of providing fire prevention and suppression service, assist in search & rescue activities with Boise County Sherriff and Bogus Basin Ski Patrol, maintain and provide First Aid facilities in the area described in Article II.

The corporation will operate and provide services primarily in the Clear Creek, Grimes Creek, Macks Creek and Pine Creek area of Boise County, State of Idaho.

This corporation is organized exclusively for charitable purposes, including, for such purpose, the making of distributions to organizations that qualify as exempt organizations under Section 501 (c) (3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law). No substantial part of the activities of this corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and this corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these articles, this corporation shall not carry on any other activities not permitted to be carried on by corporation exempt from Federal Income Tax under Section 501 (c) (3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law).

ARTICLE IV

Equipment purchased by the corporation shall be the property of the corporation and may be used by any member of the corporation for the services listed in Article III. Said loaned equipment will be the responsibility of the individual member in possession of it, i.e.; first aid equipment, flashlites, etc.

ARTICLE V

This corporation shall have no capital stock. Membership shall be by certificates rather than by shares. Certificates shall not be transferable between members. New members shall be entitled to vote and to share in the property of the association with the old members in accordance with such general rule or rules. New members will be accepted by a majority vote of the members present at a regular meeting.

ARTICLE VI

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to, its members, directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III.

ARTICLE VII

The Officers of the corporation shall be selected from the members. Their duties and method of selection shall be provided by the By-laws. The officers are Co-leaders and Secretary-Treasurer.

ARTICLE VIII

No member of this corporation shall be individually liable for the payment of the corporate debts or liabilities of the corporation.

ARTICLE IX

Upon the dissolution of the corporation, the Board of Directors shall, after paying or making provision for the payment of all of the liabilities of this corporation, dispose of all of the assets of the corporation exclusively for the purposes of the corporation in such manner, or to such organization or organizations organized and operated exclusively for charitable, religious, or scientific purposes as shall at the time qualify as an exempt organization or organizations under Section 501 (c) (3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law), as the Board of Directors shall so determine. Any such assets not so disposed of shall be disposed of by the District Court of the County in which the principal office of such corporation is located or to such organization or
