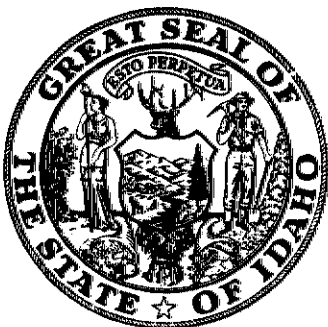

ARTICLES OF INCORPORATION

OF

The undersigned persons, in order to form a corporation pursuant to the Idaho General Business Corporations Act (Idaho Code, §30-1-1 et seq.) certify as follows:

ARTICLE I.

The name of this Corporation is: **VANDEN BOSCH WELDING, INC.**

ARTICLE II.

The period of existence and duration of the life of the Corporation shall be perpetual.

ARTICLE III.

The purposes and objects for which this Corporation is formed, and the general powers which this Corporation may exercise, are as follow:

- (a) To carry on and conduct the business of welding, and related business activities; and
- (b) To transact any and all lawful business for which a corporation may be incorporated in the State of Idaho under the General Business Corporations Act, I.C. §30-1-1 et seq., and to exercise any and all such corporate powers provided by said Act.

ARTICLE IV.

Section 1. This Corporation shall be authorized to issue one class of stock to be designated "common stock". The total number of shares of stock which this Corporation shall be authorized to issue is 1000 shares of no par value stock.

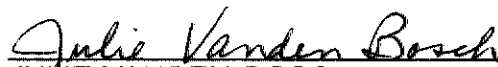
The number of Directors of this corporation shall be as provided in the By-Laws.

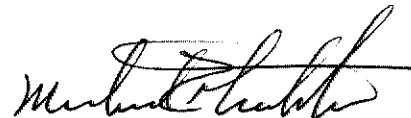
