The period of duration of the Corporation is perpetual.

ARTICLE III PURPOSE AND POWERS

Section 1. The purpose for which this Corporation is organized is: The transaction of any or all lawful business for which corporations may be incorporated under the Act; to do everything necessary, proper, advisable or convenient for the conduct of said business; and to do all other things incitent thereto or connected therewith, which are not forbidden by the Act, by other law, or by these Articles of Incorporation. m N
