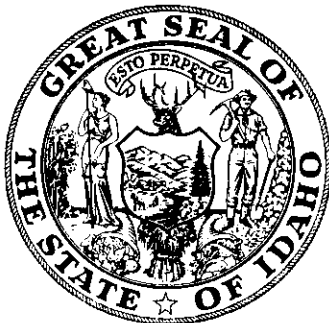

AMENDMENT TO ARTICLES OF INCORPORATION  
OF  
ROCKY MOUNTAIN SASH AND DOOR, INC.

Pursuant to the Idaho Business Corporation Act, ROCKY MOUNTAIN SASH AND DOOR, INC., an Idaho corporation, hereby adopts this Amendment to its Articles of Incorporation.

1. The name of the corporation is ROCKY MOUNTAIN SASH AND DOOR, INC.
2. Pursuant to resolution by Unanimous Written Consent of Action by the Board of Directors and Shareholders, dated February 1, 1996, the following amendment to the Articles of Incorporation was adopted:

The aggregate number of shares which this Corporation shall have authority to issue is 10,000 common shares, no par value. The Corporation shall not have the authority to issue shares in series.

3. This amendment has been unanimously approved by all the directors and shareholders of the corporation.

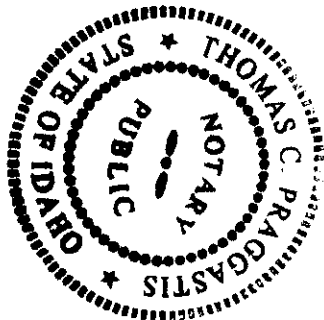
