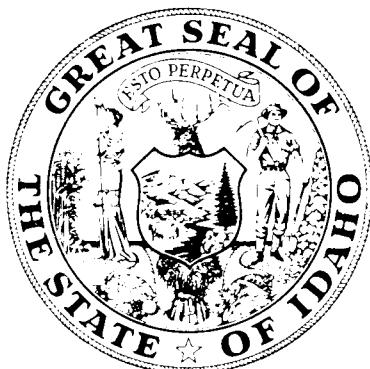

VII.

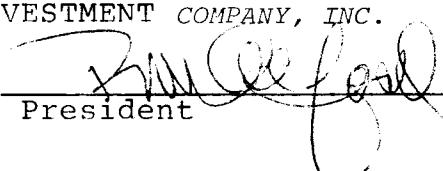
