Code §30-1-1006, hereby states as follows:

- A. The name of the corporation is Luboviski, Wygle & Fallowfield, P.A..
- B. The amendment adopted to said corporation's Articles of Incorporation is as

follows: striking out all of Article I thereof, which reads as follows:

The name of the corporation is  
Luboviski, Wygle & Fallowfield, P.A.

and by inserting in lieu thereof a new Article I reading as follows:

The name of the corporation is  
Luboviski, Wygle, Fallowfield & Ritzau, P.A.

C. The Resolution proposing such amendment was unanimously passed by the Board of Directors of the corporation on December 27, 2007. In accordance with Idaho Code §30-1-1003, such proposed amendment was subsequently unanimously approved by the three (3) sole shareholders of the corporation in writing.

D. The corporation had 300 shares outstanding at the time of such approval, all of which shares were entitled to a vote on the proposed amendment and all of which shares voted in favor of the amendment.

E. Such amendment does not provide for an exchange, reclassification or cancellation of the issued shares and does not affect the amount of stated capital of the corporation.

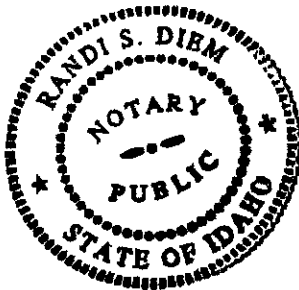

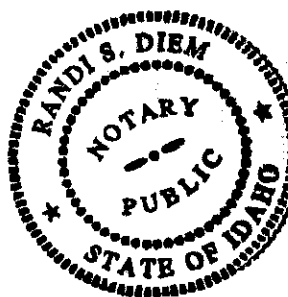
