The undersigned, desiring to form a corporation, not-for-profit, under Sections 30-301 et seq. of the Idaho Nonprofit Corporation Act, does hereby certify:

**ARTICLE I**

The name of the not-for-profit corporation shall be **AMERICAN RENTAL ASSOCIATION OF IDAHO, INC.**

**ARTICLE II**

The period of duration of the corporation is perpetual.

**ARTICLE III**

The place in Idaho where the principal office of the corporation is to be located is 580 West 19th Street, Idaho Falls, Bonneville County, Idaho 83402.

**ARTICLE IV**

The purposes for which said corporation is formed are to promote the common business interests of the equipment rental industry including those persons, corporations and entities engaged therein, at the State level and in affiliation with the American Rental Association, a national trade association representing the equipment rental industry, and to engage in any lawful activity for which corporations may be formed under the Idaho Code.

## **ARTICLE V**

The corporation shall have all the powers granted corporations under the laws of the State of Idaho. Notwithstanding anything herein to the contrary, however, the corporation shall exercise only such powers as are in furtherance of the exempt purposes of organizations set forth in Section 501 (c) (6) of the Internal Revenue Code of 1986 under which the Corporation chooses to qualify for exemption, as the same now exists, or as it may be amended from time to time.

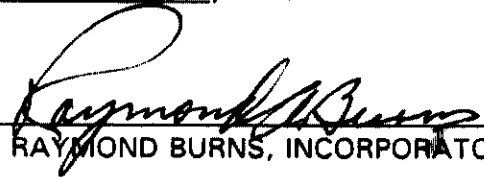
