That I, the undersigned, JAMIE MARTIN, do hereby form the following corporation pursuant to the Idaho Business Corporation Act.

ARTICLE I

The name of this Corporation shall be: NORTH IDAHO COUNSELING, INC.

ARTICLE II

The period of the duration of this Corporation shall be perpetual.
