Certificate of Amendment - Domestic Corporations

- This form may be used by both profit and non-profit corporations. In case of a non-profit corporation
 organized on a non-stock basis, "shareholders" shall be construed to be synonymous with "members"
- An effective date, not later than 90 days subsequent to the date of filing may be stated in the Certificate of Amendment.
- The Certificate of Amendment is required to be signed in ink by the chairmon or vice-chairmon of the board of directors or the president or a vice-president of the corporation.
- One original copy is required. A true copy will be prepared by the Corporation and Securities Bureau and returned to the person submitting the Certificate of Amendment for filling.
- 5. FEES: Filing Fee \$10.00 franchise Fee (payable only in case of increase in authorized capital stock) · ½ mill on each dollar of increase over highest previous authorized capital stock (Make fee payable to State of Michigan)
