

ARTICLES OF INCORPORATION OF THE

KNOW ALL MEN BY THESE PRESENTS That we, the undersigned, have this day voluntarily associated ourselves together for the purpose of forming a Corporation under the laws of the state of Idaho, and we hereby certify:

*1st* That the name of said Corporation is "Sand Point Brick Company Limited."

Second: That the purposes for which it is formed are, to manufacture pressed and repress brick and other clay products; to buy, sell, exchange and deal in all kinds of personal and real property; and to own and operate brick manufactories.

Third: That the place where it's principal business is to be transacted shall be the Village of Sand Point, county of Kootenai, State of Idaho.

Fourth: That the term for which it is to exist is fifty years from and after the date of it's incorporation.

Fifth: That the number of it's directors shall be five (5), and that the names and residences of those who are appointed for the first year are:
