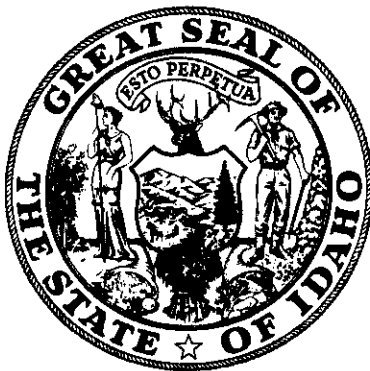

ARTICLES OF INCORPORATION  
OF  
WHITE PINE CONTRACTORS, INC.

I.

We, the undersigned, being natural persons of full age, all of whom are citizens of the United States, or of its territories or possessions, do hereby voluntarily associate ourselves for the purpose of forming a private corporation, under the laws of the STATE OF IDAHO.

II.

The name of the proposed corporation is WHITE PINE CONTRACTORS, INC.

III.

The period of it's duration is perpetual.

IV.

The location and address of the registered office of this corporation shall be *Eugene Walter 425 Larch St* Potlatch, Idaho 83855.

V.

The purpose of the corporation is the transaction of any or all lawful business for which corporations may be incorporated under this act. In furtherance, and not in limitation of the general powers conferred by the laws of the State of Idaho, this corporation shall have the following objects, purposes and powers:

To engage in general construction work, including the installation of underground utility systems such as water and sewer systems, electrical systems, and telephone transmission systems.

To acquire, hold, own, use, lease, let, mortgage, hypothecate, pledge, sell or otherwise dispose of all manner of real or personal property whatsoever that may be reasonably necessary for the purpose of carrying into effect any one or more of the objects of this corporation.

To make and enter into all necessary contracts and agreements, to borrow money, to lend money, to evidence the indebtedness of the corporation by notes, bonds, or other instruments and to secure the same by pledge, mortgage,

trust deed or other instruments and to do all acts, and make, execute and deliver all necessary instruments for the carrying out of the purposes of this corporation; to acquire and own the stock, bonds and securities of other corporations while owning the same to exercise all the privileges of ownership consistent with the corporate character of this corporation.

To act either as, or by and through principals, agents, attorneys, trustees, contractors, factors, lessors, lessees or otherwise, either alone or in connection with others; to do any and all things convenient and incidental to the purposes herein expressed, and generally to have and exercise all powers as are by law conferred on corporations of like character, without in any particular limiting any of the powers or purposes of the corporation, and in connection with its objects to do any and all things and to exercise any and all powers not prohibited by law.

VII.

The stock to be issued by this corporation shall be One Dollar (\$1.00) par value common stock. The total number of shares authorized to be issued shall be Twenty Five Thousand (25,000) shares of common stock, and the holders and the owners thereof shall have and acquire such voting rights in said corporation as provided by the laws of the STATE OF IDAHO. The stock issued by this corporation shall be non-assessable.
