# ARTICLES OF INCORPORATION

OF

BURLEY AREA CHAMBER OF COMMERCE, INC.

We, the undersigned persons, being residents of the State of Idaho, and of full age, do hereby associate ourselves together for the purposes of forming a non-profit corporation; for the purposes hereinafter set forth, under the laws of the State of Idaho relative to corporations; and that corporations, associations and co-partnerships may become incorporators and members of this incorporation.

## ARTICLE ONE.

### NAME

The name of the Corporation shall be:

BURLEY AREA CHAMBER OF COMMERCE, INC

## ARTICLE TWO.

### LOCATION

The initial registered office shall be 1401 Overland Avenue, Burley, Idaho and it's initial registered agent at such street address shall be Nick James Cozakos.

## ARTICLE THREE.

### DURATION

The period of the duration of this corporation is perpetual.

## ARTICLE FOUR.

### MEMBERSHIP

The corporation shall be nonstock, and no dividends or pecuniary profits shall be declared or paid to the members thereof; but shall issue membership certificates to each member thereof, and the rights and interest of all members shall be equal.

## ARTICLE FIVE.

### PURPOSES

The business and purpose of this corporation shall be the advancing of agricultural, professional, commercial, industrial,

civic, tourism, recreational and general interests of the City of Burley and it's trade area.

#### ARTICLE SEVEN.


##### BOARD OF DIRECTORS


1. 
