ARTICLES OF INCORPORATION

OF

D. Q. TRUCKING, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is D. Q. Trucking, Inc.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 5,000 at no par value.

FIFTH: Provisions denying preemptive rights are: NONE

SIXTH: Any actions and/or decisions made by either the Board of Directors or the shareholders must be approved by unanimous vote. Other provisions for the regulation of the internal affairs of the corporation are contained in the By-Laws of the corporation.
