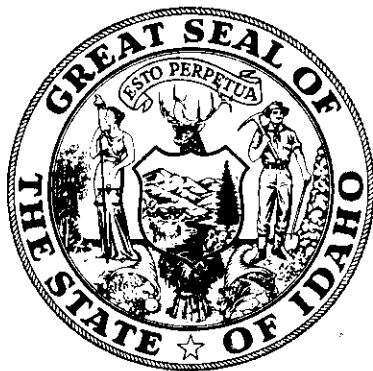

The following are Articles of Incorporation set forth
this day, July 20, 1982, in accordance with section
30-323 Idaho Code:

- ARTICLE NO. 1 The name of the corporation shall be the Kuna Church of Christ, Incorporated.
- ARTICLE NO. 2 The Kuna Church of Christ, Incorporated shall exist entirely as a non-profit organization.
- ARTICLE NO. 3 The period of duration for this corporation shall be perpetual.
- ARTICLE NO. 4 The corporation shall be organized solely for the purpose of teaching the Bible.
- ARTICLE NO. 5 The corporation will have a membership.
- ARTICLE NO. 6 The membership shall comprise the corporation, the directors to which, shall be elected by the membership.
- ARTICLE NO. 7 The decision-making process and initial representation of the corporation shall be shared by all male members awaiting such time when elders will be appointed.
- ARTICLE NO. 8 The permanent mailing address for the corporation shall be P.O. box 303 Kuna, Idaho. 83634 with the temporary initial registered agent being Terry C. MacDonald at 378 Ash St. Kuna, Idaho. 83634.
