undersigned, acting as incorporators corporation under the Idaho Non-Profit Corporation Act, adopt the following Articles of Incorporation for such corporation.

ARTICLE I

Name

The name of the corporation is GIRL'S ATHLETIC LEAGUE SOFTBALL, INC.

ARTICLE II

Non-Profit Corporation

This corporation is a non-profit corporation, and no part of the net earnings shall inure to the benefit of any 14 private shareholder.

ARTICLE III

Duration

The period of its duration is perpetual.

ARTICLE IV

Purpose

The purpose for which this corporation is formed is for the promotion of social welfare. Exclusively to teach, 21 promote and facilitate the playing of the game of baseball among To promote and maintain high standards of conduct and youth. 22 sportsmanship of players, parents, spectators and coaches. To provide a unified organized female youth softball program all within the meaning of §501(c)(4) of the <u>Internal Revenue Code</u>. Notwithstanding any other provisions of these articles, the 24 corporation shall not carry on any other activity not permitted to be carried on by an organization exempt from federal income tax under §501(c)(4) of the <u>Internal Revenue Code</u>.
