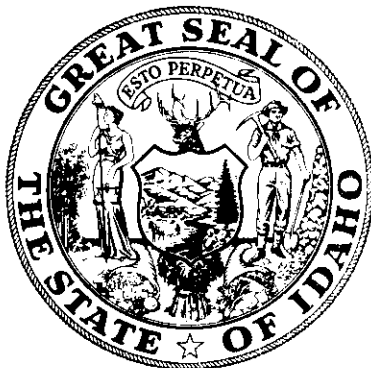

ARTICLES OF INCORPORATION  
OF

*Gigray* GIRL'S ATHLETIC LEAGUE SOFTBALL, INC.  
(A Non-Profit Corporation)

The undersigned, acting as incorporators of a corporation under the Idaho Non-Profit Corporation Act, adopt the following Articles of Incorporation for such corporation.

ARTICLE I

Name

The name of the corporation is GIRL'S ATHLETIC LEAGUE SOFTBALL, INC.

ARTICLE II

Non-Profit Corporation

This corporation is a non-profit corporation, and no part of the net earnings shall inure to the benefit of any private shareholder.

ARTICLE III

Duration

The period of its duration is perpetual.

ARTICLE IV

Purpose

The purpose for which this corporation is formed is for the promotion of social welfare. Exclusively to teach, promote and facilitate the playing of the game of baseball among youth. To promote and maintain high standards of conduct and sportsmanship of players, parents, spectators and coaches. To provide a unified organized female youth softball program all within the meaning of §501(c)(4) of the Internal Revenue Code. Notwithstanding any other provisions of these articles, the corporation shall not carry on any other activity not permitted to be carried on by an organization exempt from federal income tax under §501(c)(4) of the Internal Revenue Code.

ARTICLE V

Initial Registered Office

The address of the initial registered office of this non-profit organization is Post Office Box 640, 9th and Dearborn Streets, Caldwell, Idaho, 83605, and the name of this non-profit corporation's initial registered agent at such address is Wm. F. Gigray, III.

ARTICLE VI

Dissolution Provision

In the event of the winding up and dissolution of this corporation, after paying or adequately providing for the debts and obligations of the organization, the remaining assets shall be distributed to a non-profit fund, foundation or corporation which has established its tax exempt status under §501(c)(4) of the Internal Revenue Code.

ARTICLE VII

Board of Directors

A. The business of this corporation shall be managed by a Board of Directors, and the number of directors constituting the initial Board of Directors shall be six (6).

B. The number of Directors, their qualifications, term of office, manner of election, time and place, and manner of calling meetings, and the powers and duties of Directors may be subject to the provisions of the By-Laws of this corporation.

C. Unless otherwise specified by the By-Laws, a Director's term shall be for one (1) year.

D. The names and addresses of the persons who constitute the initial Board of Directors and who are to serve as Directors until the first annual meeting, or until their successors are elected and shall qualify are:






