That I, the undersigned, am duly licensed to render professional services as a veterinarian, acting as incorporator of a Professional Service Corporation under the laws of the State of Idaho, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is ADDISON ANIMAL CLINIC, P.A.

SECOND: The period of its duration is perpetual.

THIRD: The purpose for which the corporation is formed is to engage in the general practice of veterinary medicine and to have and to exercise all the powers now or hereafter conferred by the laws of the State of Idaho upon corporations organized pursuant to the laws under which the corporation is organized and any and all acts amendatory thereto and supplemental thereto.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 100,000 shares, all of which are to be without par value.
