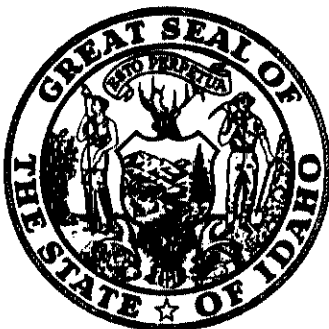

Pursuant to the provisions of Section 30-1-61 of the Idaho Business Corporation Act, PolCentrix Technologies, Inc. has adopted the following Articles of Amendment to its Articles of Incorporation:

I

The name of the corporation is PolCentrix Technologies, Inc.

II

The following amendment of the Articles of Incorporation was adopted by the shareholders and directors of the corporation on March 11, 1994, in the manner prescribed by the Idaho Business Corporation Act:

RESOLVED, that Article VI of the Articles of Incorporation of the corporation be amended to read as follows:

VI

The aggregate number of shares which this corporation shall have authority to issue shall be two thousand shares of nonassessable, common stock having a par value of one cent per share.

III

The number of shares of the corporation outstanding at the time of such adoption was 1,000 and the number of shares entitled to vote thereon was 1,000.

IV

The number of shares voted for such amendment was 1,000 and the number of shares voted against such amendment was 0.00.

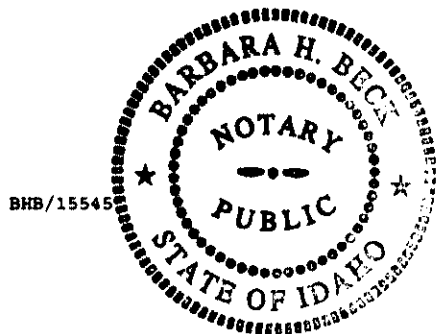
