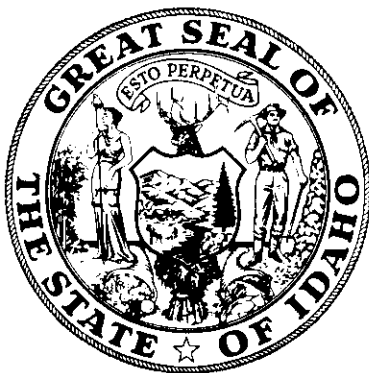

We, the undersigned, being three persons of full age, at least two of whom are citizens of the United States or of its territories or possessions, have this day, voluntarily associated ourselves for the purpose of forming a private corporation under the laws of the State of Idaho, and to that end hereby adopt Articles of Incorporation, as follows:

ARTICLE ONE

NAME: The name of the corporation is ROCKY MOUNTAIN WHOLESALERS, INC.

ARTICLE TWO

PURPOSE: The purpose of the corporation is to have and to exercise all the powers now or hereafter conferred by the laws of the State of Idaho upon corporations organized pursuant to the laws under which the corporation is organized and any and all acts amendatory thereof and supplemental thereto.

ARTICLE THREE

DURATION: The duration of the corporation is perpetual.

ARTICLE FOUR

LOCATION: The location and post office address of the registered office of the corporation is in the State of Idaho, to wit: 5140 East Seltice Way, Coeur d'Alene, Idaho, 83814. The name of the corporation's initial registered agent at such address is GARY HALL.

ARTICLE FIVE

STOCKS: The aggregate number of shares which the corporation shall have authority to issue is 20,000 with a par value of ONE DOLLAR (\$1.00) per share.






