ARTICLES OF AMENDMENT to the ARTICLES OF INCORPORATION of O.K. LIVESTOCK EXCHANGE, INC.

SECNETARY OF S

Pursuant to the provisions of the Idaho General Business Corporation Act (Chapter 1, Title 30, <u>Idaho Code</u>), the undersigned corporation adopts these Articles of Amendment to its Articles of Incorporation:

(1) Prior to the adoption of this amendment to the Article of Incorporation, Article IV read as follows:

The capital stock of this corporation shall consist of 1,000 shares of common stock at no par value.

(2) The following amendment to the Articles of Incorporation was adopted by the shareholders, and Article IV is now amended to read as follows:

The capital stock of this Corporation shall consist of Thirty Thousand (30,000) shares of common stock with a par value of One Hundred dollars (\$100.00) per share.

- (3) The foregoing amendment to the Articles of Incorporation was adopted by unanimous shareholder written consent pursuant to Idaho Code 30-1-59, as evidenced by the Minutes of the Board of Directors, attached hereto and incorporated herein as if they were set forth in full.

 This urmendment increases stated capital to 43000000.
- (4) There were 1,000 shares of stock of the corporation outstanding at the time of the adoption of the foregoing amendment. All shares were common shares of the same class, and all shares were entitled to vote on the amendment.
- (5) All shareholders agreed to the Amendment in writing. Therefore, all 1,000 shares were for the Amendment with no opposition votes.
